

\$200,000,000 Israeli Challenge Funds; for financing Mossad projects.




David Ivry, Challenge Funds Advisory Board.

President of Boeing [Israel]; Commander of the Israel Air Force (1977-82); Director General of the Ministry of Defense (1986-96); Israel's chief representative to the U.S.-Israel Strategic Dialogue; Minister of Strategic Affairs at the Israeli Prime Minister's office from 1996 to 1999; Israeli Ambassador to the U.S. from January 2000 through 2002. Ivry has twice served as Chairman of the Board of Israel Aircraft Industries (IAI). Ivry also directed the IAF's criminal destruction of the Osirak nuclear reactor in Iraq. In 1962, Ivry was involved in the criminal Israeli attack on the U.S.S. Liberty with Mirage fighters. (Thirty-four American servicemen were killed and 172 wounded in the Israeli attack.)
